The Chairman welcomed the Members of the Committee and explained the Scheme in brief and mentioned the conventions and practices that stood evolved as to the conduct of the meetings of the Committee.

The Chairman thereafter invited the Committee to consider the agenda and make its recommendations.

The Committee discussed the agenda and observed that a large number of applicant organizations and individuals did not qualify for grant as envisaged under the scheme. While taking note of the fact that the scheme is meant for professional groups/individuals, the Committee shortlisted the eligible cases and recommended grants subject to submission of complete documents by them. (It is put on record that a declaration of interest was obtained from the members and when any case(s) of grant to organizations run by a member of the Expert Committee was being considered, the concerned member left the meeting room). The recommendations are as detailed hereunder:-

5. Review Case

The Committee observed that the Salary Grant of M/s Blind Opera, 8, Dinanath Chatterjee Street, Kolkata had been discontinued w.e.f. 2008-09 by the Expert Committee which met on 4th February, 2009. The recommendation was based on the adverse report received from the concerned State Government. However, on receipt of a representation from the organization, a fresh report from State Government and dismissal of the dispute in court, the case was brought before the Committee for review. After going through the documents available in the concerned file (No.F.10-449/07-P.Arts), the Committee recommended that the salary grant of the organization may be revived w.e.f. 2008-09 itself i.e. w.e.f. 01.04.2008.

6. Doubtful cases of Production Grant Applications

The Committee observed that the applications of the following 57 organisations pertaining to Andhra Pradesh had the following defects/deficiencies:-

- (i) The State Government recommendations do not appear to be proper, inasmuch as the letter addressed to the Ministry of Culture is not signed. The signed copy endorsed to Principal Secretary, Government of Andhra Pradesh is attached with the applications/proposals.
- (ii) In almost all the cases, the non-judicial papers are purchased from Delhi from one or two vendors on 16/02/2009 whereas the date of State Government recommendation letters is 2.01.2009.
- (iii) The covering letter of the applicants, bond etc. appears to be identical in almost all the applications.
- (iv) The Bank Authorization letter attached with the applications contains the name of same bank with same Account Number in almost all these proposals.

The Committee further observed that the applications of the following 41 organisations pertaining to Karnataka also had similar defects/deficiencies:-

- (i) In almost all the cases, the non-judicial papers are purchased from Delhi from one or two vendors on 16/02/2009 whereas the date of State Government recommendation letters is 2.01.2009.
- (ii) In some cases, the Sl.Nos. in front of the non-judicial stamp papers are different from the numbers mentioned on the back side.
- (iii) The applications and other documents in almost all cases, are identical/similar.

- (iv) The Bank Authorization letter attached with the applications contains the name of same bank with same Account No. in almost all these proposals.

In view of the above, the Committee unanimously decided not to recommend grant to any of these organizations and summarily rejected these 57+41 applications.

7. Cases relating to existing Salary Grantees:-

(i) Vivechana, PD 4, Perfect Enclave, Snehnagar, Jabalpur, M.P.

The Expert Committee, which met on 4th February, 2009 for considering the renewal of Salary Grant for the year 2008-09 to the existing grantees had recommended the renewal of salary for 1 Guru and 6 Artistes to this organization. However, it was observed by this Committee that the said organization in their salary grant application dated 4.2.2009 (received after the Expert Committee meeting dated 4th February, 2009) had sought salary grant for 1 Guru and 5 Artistes. This Committee considered the request of the organization and in supersession of its earlier recommendation, recommended salary grant for 1 Guru and 5 Artistes w.e.f. 2008-09.

(ii) Vipanchee, No.113, 4th street, "Vipanchee", Karpagam Avenue, R.A. Puram, Chennai- 60028, TN.

As regards this organization, the Committee was informed that due to the oversight the case of renewal of salary grant of this organization could not be placed before the Expert Committee, which met on 4th February 2009. Therefore, a salary grant application dated 20.2.2009 of this organization was placed before the Committee. The Committee went through the application and recommended the renewal of salary grant for year 2008-09 alongwith enhancement of 1 artiste.
